ORDER

Sri K P Noushad, Kondadan Parampil, Pazhayangadi, Kondotty had submitted a request in the Adalath to waive the MG dues of dismantled consumer no. 18898(9/2008 to 3/2011). The Deputy Chief Engineer,Electrical Circle,Manjeri as per letters read as 1st above has reported that the service connection to Sri. Noushad was effected on 17.10.2004 as per the Minimum Guarantee agreement. The consumer has not remitted the UCM amount from 9/2008 to 3/2011.The total amount due by the consumer from 15/09/2008 to 07/03/2011 is Rs 1,41,848/-.

It is reported that an amount of Rs 3,03,131/-towards current charges has been collected from 48 nos of consumers connected under the transformer during the MG period for the past three years and the dues have become self remunerative. The decision of the Adalath Committee was to take up the matter with the State Level Expert Committee (SLEC) and forwarded on 18/08/2020. The State Level Expert Committee informed that the adalath petitions pending for disposal can be settled at the field offices by adhering the guide lines issued vide Office Order

(CMD) No.226/2021(TRAC/GL/Ots-2021/20-21) dated 15/02/2021 dated 15.02.2021 and Board Order BO(FTD) No.175/2021(TRAC/GL/Ots-2021/20-21) dated,Thiruvananthapuram 26.02.2021

The matter was placed before the Full Time Directors as per note read as 3rd above for a decision.

Having considered the matter in detail, the Full Time Directors in the meeting held on 04.08.2021, resolved to accord sanction to the the Deputy Chief Engineer, Electrical Circle, Manjeri to waive the arrear amount of Rs 1,41,848/-,(UCM charges under Minimum Guarantee Scheme) of the connection in favour of Sri.Noushad K P from 9/2008 to 3/2011, considering that the scheme have become self remunerative and the petition was received in Adalath 2020.

Orders are issued accordingly.
