The Manager, KSEB Volleyball (Men) team as per submission read above has informed that Sri.Sunny Joseph, Coach of the team has undergone treatment for knee injury from 10th to 25th March 2021 and hence he could not attend the coaching camp during that period. He has also requested to grant monthly honorarium to Sri.Sunny Joseph for the above period also since Sri.Sunny Joseph has given a scheduled training plan for the team even though he was undergoing treatment. The Sports Co-ordinator vide note read above has recommended to consider the request of the Manager of the team.

Having considered the matter in detail, the Full Time Directors in its meeting held on 04-08-2021,

Resolved to accord sanction for the payment of monthly honorarium to Sri.Sunny Joseph, Coach, KSEB Volleyball (Men) team for the period from 10th to 25th March 2021 also.
