## ORDER

Purchase Order read as 1<sup>st</sup> above was placed with M/s.Mehru Electrical and Mechanical Engineers Pvt. Limited, Rajastan (MSME) for the supply of 16 Nos. 220kV Current Transformers (Live Tank Type) of various ratings, 223 Nos. 110kV Current Transformers (Live Tank Type) of various ratings and 136 Nos. Supporting structures of 110kV CTs with a total contract value of Rs. 4,40,03,356/-.

As per the terms and conditions of the Purchase Order, supply shall commence within 4 months and complete within 6 months from the date of Purchase Order as detailed below:

The firm has to complete the supply of the first lot by 31/05/2021. Drawings were approved vide letter dated 20/03/2021.

The firm has requested delivery period extension upto October 2021 and requested that their production facilities are severely affected due to lock down and non availability of raw materials consequent to the wave of Covid infections. The firm also informed that the use of Oxygen in Industries has been banned due to extreme shortage of Oxygen and so fabrication of tanks, Copper brazing and other activities at the firm and their vendors have been forced to shut down since April 2021. Since their vendors are located at Delhi, Rajastan and Maharashtra, manufacturing is at slow pace due to intermittent lock down. Also lot of the firm's workers are Corona +ve and the firm is forced to work with 50% staff since March 2021.
