ABSTRACT

Rebuild Kerala Initiative (RKI) of the Government of Kerala – Kuttanad Package – Construction of a new 33kV Substation at Kidangara - Administrative Sanction – Orders issued.

ORDER

The Government of Kerala as per G.O read as 1st above has accorded revised Administrative Sanction for the project proposed by Kerala State Electricity Board Limited, viz. Kuttanad Flood Resilience Package under Rebuild Kerala Initiative at a total cost of Rs 53.55 Crore (Rupees Fifty Three Crores and Fifty Five Lakh only). The project proposal comprises of upgradation of 66kV Substation, Kuttanadu, construction of new 110kV Gas Insulated Substation at Kavalam, and construction of new 33kV Substation at Kidangara. The project will be funded by Government of Kerala, by sourcing the fund from the World Bank's Development Policy Loan.

Out of the three parts of the package, the construction of new 33KV substation at Kidangara with 2x5MVA capacity in elevated design forms the third part. The works involves for the particular project are:

- a. Construction of 33kV Substation at Kidangara
- b. Construction of 1 No. 33kV feeder bay at 110kV Substation, Edathua for feeding the Kidangara Substation.
- c. Construction of 10km 33kV SC line using covered conductors.

The Chief Engineer (Transmission South) as per note read as 2nd above has forwarded an estimate amounting to Rs.13.80Cr, which includes the cost of construction of Substation - Rs.7.08Cr, cost for 33kV bay at Edathua Substation - Rs.0.27Cr and cost of line works (including Tree cutting compensation and PTCC approval) - Rs 6.45Cr.

The Chief Engineer (Trans. South), as per note read as 2nd above, has requested Board's Administrative Sanction for the said project. In view of the revised sanction issued by the Government, it is suggested to issue Administrative Sanction from the Board.

The matter was placed before the Full Time Directors for sanction as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 04.08.2021,

Resolved to accord Administrative Sanction for the construction of 33kV Substation at Kidangara, included in the Kuttanad Flood Resilience Package under Rebuild Kerala Initiative (RKI) of the Government of Kerala, at an estimate amounting to Rs.13.80Cr. (Rupees Thirteen Crore Eighty Lakh Only).
