ORDER

As per B.O. read as 1st above, sanction was accorded for purchasing 13 cents of land in Re-Survey No. 624/7, 624/8 & 624/9 (4.31, 5.25 & 2.41 Ares) of Thrikkovilvattom Village, Kollam Taluk and Kollam District owned by Sri. Sunil Kumar N., Anil Bhavan, Maroor, Kudavattoor P.O. for the construction of a building for accommodating Electrical Section, Kannanalloor, since no buildings or land owned by KSEB Ltd is available there for accommodating the office which is now functioning in an old, dilapidated rented building.

Later, as per B.O. read as 2nd above, sanction was accorded to the Deputy Chief Engineer, Electrical Circle, Kollam for remitting an amount of ₹1,29,922/- as 5% of contingency charges for acquisition of the above land.

As per B.O. read as 3rd above, sanction was accorded to the Deputy Chief Engineer, Electrical Circle, Kollam for remitting an amount of ₹7,79,532/- as establishment charges for the acquisition of land for constructing a building for Electrical Section, Kannanalloor.

As per B.O. read as 4th above, sanction was accorded to the Deputy Chief Engineer, Electrical Circle, Kollam for remitting an amount of ₹73,42,587/- towards the balance amount for purchasing 5.27 Ares (13 cents) of land for constructing a building to accommodate Electrical Section, Kannanalloor.

The Deputy Chief Engineer, Electrical Circle, Kollam as per letter read as 5th above reported that a total amount of ₹82,52,041/- has already been remitted to the Government Treasury on 26/05/2021 towards the purchase of the above land. The Special Tahsildar LA No. 2, Kollam had requested to remit an amount of ₹25,146/- (₹19,558/- towards compensation & contingency charges and ₹5,588/- towards establishment cost) as the balance amount for the above purchase.

The Deputy Chief Engineer, Kollam requested sanction to remit the amount to proceed in this regard.

In the matter the Financial Adviser as per note read as 6th above has recommended to accord sanction to remit the balance amount of ₹25,146/-.

The matter was placed before the Full Time Directors as per the note read as 7th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 04/08/2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kollam for remitting the balance amount of ₹25,146/- towards revised assessment upto 30/06/2021 (₹19,558/- towards compensation & contingency charges and ₹5,588/- towards establishment cost) for the purchase of 5.27 Ares (13 cents) of land in Re-Survey No. 624/7, 624/8 & 624/9 of Thrikkovilvattom Village, Kollam Taluk and Kollam District for constructing a building to accommodate Electrical Section, Kannanalloor.

Orders are issued accordingly.
