Construction of building for accommodating Electrical Sub Division and Electrical Section, Cherpulassery under Electrical Circle, Shoranur – Approval of plan and Administrative Sanction – Accorded – Orders issued

ORDER

As per the letters read as 1st above, the Chief Engineer (Distribution North), Kozhikode reported that Electrical Sub Division and Electrical Section, Cherpulassery under Electrical Circle, Shoranur are presently functioning in two separate old rented buildings. Suitable land is available in the Substation compound for constructing a new building to accommodate these offices. The Director (Transmission & System Operation) had given consent to hand over 25cents of vacant land from 110 kV Substation premises, Cherpulassery to the Distribution wing for the construction of Electrical Sub Division and Electrical Section, Cherpulassery.

The Chief Engineer (Distribution North), Kozhikode has reported that the plot is having high level difference and hence a retaining wall is to be constructed. It is proposed to construct a double storied building having a total plinth area of 202.81 m² [Cellar floor – 99.28 m², Ground floor – 103.53 m²] for accommodating Electrical Sub Division and Electrical Section, Cherpulassery with an approximate estimate amount of ₹75,00,000/-.

In the above circumstances, the Chief Engineer (Distribution North), Kozhikode requested Administrative sanction for an amount of ₹75,00,000/- for constructing a building for accommodating Electrical Sub Division and Electrical Section, Cherpulassery in the land available at 110 kV Substation, Cherpulassery.

The matter was placed before the Full Time Directors as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 04/08/2021, resolved to accord sanction for constructing a double storeyed building for accommodating the Electrical Sub Division and Electrical Section, Cherpulassery in the land available at 110 kV Substation, Cherpulassery.

Further resolved to approve the plan for the construction of the building having a total plinth area of 202.81 m² [Cellar floor – 99.28 m², Ground floor – 103.53 m²] by limiting the total cost of construction to ₹75,00,000/-:
