ORDER

The Chief Engineer Distribution (Central) , as per letter read as 1st above, has informed that competitive E tenders were invited by the Executive Engineer, Project Management Unit, Thodupuzha for the work of shifting of 11kV OH line using A Pole from Moolepeedika to Karimkunnam Madam under Electrical Section, Purapuzha with the PAC of Rs.5,28,041/-, from licensed/ experienced contractors, after giving wide publicity as per norms prevailing in KSEBL. Only one tender was received in time even after time extension.

Hence, the work was re-tendered. But only one tender was received in time. Again new E-tender was initiated, for more competitive participations and only single bid was received in time even after time extension. The tender summary is as follows:

Since the work was tendered three times with time extensions, there is no chance to get a better offer during further re tendering, the rock bottom rate was sought from the tenderer and in reply the tenderer informed that they cannot offer reduced rates because of the pandemic situations.

Further negotiation was made from the office of Chief Engineer, Distribution (Central). But the bidder was not willing to reduce the rate further, due to the Covid 19 pandemic situation.

Hence sanction is requested to award the work of shifting 11kV OH line using A pole from Moolepeedika to Karimkunnam Madam under Electrical Section, Purapuzha to Sri. Shanthy P. Kuruvilla at the rock bottom amount of Rs. 4,98,999/- (Rupees Four Lakh Ninety Eight Thousand Nine Hundred and Ninety Nine only) (including GST), which is 5.5% below the estimate rate.

The matter was placed before the Full Time Directors as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 04.08.2021, resolved to accord sanction to the Executive Engineer, Project Management Unit, Thodupuzha for awarding the work of "shifting of 11kV OH line using A Pole from Moolepeedika to Karimkunnam Madam" under Electrical Section, Purapuzha to Sri. Shanthy P Kuruvilla, Pushpamangalam, Ernakulam (Joint ventured with licensed contractor Sri. Abhilash K.V.) at their quoted rate of 5.5% below estimate rate which amounts to Rs. 4,98,999/-.
