ORDER

The Deputy Chief Engineer, Electrical Circle, Vadakara as per letter read as 1st above has reported that Sri. Vipindas under Electrical Section, Chakkittapara belonging to the SC category had submitted an application to the Assistant Engineer,Electrical Section Chakkittapara for shifting of LT single phase line passing above his newly constructing house. The construction of the house is going on with the financial aid of Block Panchayath. An estimate has been prepared for Rs 14450/- for the work including material and labour portion.

It is reported that the applicant had submitted a petition in the Lok Adalath requested for exemption from shifting charges since he cannot afford the same. The Lok Adalath in it's award dated 10.04.2021 has directed KSEBL to take needful action in this regard.

The applicant had furnished an income certificate with an annual family income of Rs 48000/- as certified by the Village officer, Changaroth.

The matter was placed before the Full Time Directors as per note read as 3rd above for a decision.

Having considered the matter in detail, the Full Time Directors in the meeting held on 04.08.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Vadakara for carrying out the work of " Shifting of existing LT OH line passing above the newly constructing house of Sri. Vipindas, Ottakkandathil House under Electrical Section, Chakkittapara" by using Board's fund considering the financial constraints of the beneficiary and the decision of the Lok Adalath , as a special case.

Orders are issued accordingly.
