ORDER

M/s. Silver Storm Amusement park (P) Ltd is an HT consumer (LCN 4/3765) of Electrical Section, Pariyaram with Contract Demand of 360kVA. The Deputy Chief Engineer, Electrical Circle, Irinjalakuda, as per letter read 1st above, informed that they have requested for reduction in contract demand to 66kVA without change in connected load. The Administrative Sanction for the works were issued on 23.09.2020. They have submitted the documents for executing fresh agreement for the reduction in contract demand. But, on scrutiny it was seen that an arrear for an amount of Rs.40,15,821/- was pending against the consumer, for payment as on 01.06.2021. Further, 10 number of installments were sanctioned on 16.03.2021 from the office of the Special Officer Revenue, out of which they have remitted only the first installment on 29.03.2021. The direction was issued to the consumer to remit the upto date installments for processing the request for reduction of contract demand. But in reply they have informed that they are facing acute financial crisis due to the spread of the pandemic Covid19 and closure of their park and are not in a position to remit the installments.

The Deputy Chief Engineer, Electrical Circle Irinjalakuda has requested on whether their application for reducing their contract demand may be considered for action with pending arrears.

The matter was placed before the Full Time Directors as per the note read as 2nd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 04.08.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle,

Irinjalakuda to proceed with the reduction in contract demand of M/s. Silver Storm Amusement Park (P) Ltd, after obtaining an undertaking to remit the pending arrears at the earliest.

Orders are issued accordingly.
