ORDER

The Ministry of Jal Shakti as per letter read as 1st above has informed that IIT, Roorkee, IIT, Chennai & IISC Bangalore will be starting the post graduate programme in Dam Engineering in academic session 2021 under DRIP Phase II. It was also informed that the expenditure for the sponsored candidates for admission as well as expenditure related to this course is eligible to be booked under the component Institutional Strengthening under 2nd Phase of DRIP.

Accordingly, KSEBL as per the B.O read as 2nd above had accorded sanction to select Sri Arun V.H., Assistant Engineer, RMU Sub Division, Poringalkuthu and Sri Renju Francis, Assistant Engineer, Electrical Circle, Ernakulam for the Post Graduate program in Dam Engineering conducted by IIT Roorkee /IIT Chennai/ IISC Bangalore being a sponsorship programme under DRIP II. Later, KSEBL as per the B.O read as 3rd above had modified the decision conveyed as per B.O read as 2nd above to the extent that, permission shall be issued to four engineers to attend the interview for admission to the P G course in Dam Engineering conducted by IIT Roorkee on condition that KSEBL will sponsor maximum two officers to the program subject to the conditions stipulated in the Board Order.

Now the Chief Engineer (Civil – Dam Safety & DRIP) as per note read as 5th above has reported that IISC Bangalore & IIT Roorkee had conducted interviews and three officers are selected for the M-Tech program.

- 1. Sri Arun V.H., Assistant Engineer, RMU Sub Division, Poringalkuthu.
- 2. Sri Hari Krishnan K S, Assistant Engineer, O/o the Chief Engineer (Civil Construction South).
- 3. Smt. Priyanka S, Assistant Engineer, O/o the Chief Engineer (Civil Construction South).

Accordingly KSEBL as per the Office Order read as 4th above accorded sanction to sponsor two Engineers Sri.Hari Krishnan.K.S, Asst Engineer, O/o Chief engineer (Civil-Construction) South and Smt.Priyanka.S, Asst Engineer, O/o Chief Engineer (Civil-Construction) South for the Post Graduate programme in Dam Engineering course conducted by the IIT Roorkee subject to the conditions stipulated in the Board Order.

The Chief Engineer (Civil – Dam Safety & DRIP) in the note read as 5th above has reported that as a part of the Institutional strengthening programme under DRIP phase II, it is possible to build up a cadre of Dam safety professionals to ensure long sustainability of Dam Management. Hence the Chief Engineer (Civil – Dam Safety & DRIP) recommended to grant permission to all the three selected officers to join the M Tech Program with service benefits, subject to the conditions stipulated by the Board as per B. O. read as 3rd above and as per the rules prevailing in KSEBL. It is also requested to grant permission to the selected officers to remit the fee as informed by the respective institutions and to book and reimburse the expenditure under the component Institutional Strengthening under 2nd Phase of DRIP.

The matter was placed before the Full Time Directors as per note read as 6th above.

Having considered the matter in detail, the Full Time Directors through circulation on 29.07.2021 resolved to accord sanction:

- To sponsor Sri.Arun.V.H, Assistant Engineer, RMU Sub Division, Poringalkuthu also to M Tech Program in the Department of Civil Engineering (with a major in Dam Engineering) under sponsored category at IISC Bangalore in addition to the two Engineers Sri.Hari Krishnan.K.S, Asst Engineer, O/o Chief Engineer (Civil-Construction) South and Smt.Priyanka. S, Asst Engineer, O/o Chief Engineer (Civil-Construction) South sponsored vide Office Order(CMD)No. 846/2021 (DGC/AEE-II/DRIP/General/2018) dated 28.07.2021 subject to the following conditions.
 - No protection from transfer will be allowed on the ground of attending this Post Graduate program.
 - (ii) They shall execute a Bond to the effect that they will continue to serve KSEBL for a minimum period of 10 years in the respective field after acquiring the qualification.
 - (iii) Permission will not be granted for deputation to other departments.
 - (iv) Any other conditions as deemed by KSEBL.
- To grant service benefits to all the above three Engineers as per the rules prevailing in KSEBL.
- 3. To grant permission to the selected officers to remit the fee as informed by the respective institutions and to book and reimburse the expenditure under the component Institutional Strengthening under 2nd Phase of DRIP.
