ABSTRACT

Re connecting service connections in favour of Smt,Annakutty (Con No 1167964003138&3139) dismantled during the flood 2018&2019- Complaint through Adalath 2020-Sanctioned - Orders issued.

ORDER

The Executive Engineer in Charge,Electrical Circle,Nilambur per letter read as 1st above has reported that Smt. Annakutty had submitted an application for reconnecting the two service connections of domestic and Agricultural purposes. Both the connections were near to the Mathilmoola colony which were completely destroyed in the flood during 2018 and 2019 and were dismantled. Taking into account the threat of further floods,the relatively unsafe conditions for drawing electric lines,the power supply has not yet been restored.

The District Collector,Malappuram directed not to reconnect the services in the Mathilmoola colony as the area is not in a position to live. The service line of Smt.Annakutty is passing through this colony ,hence reconnection of the two service connections were not done based on the direction from the District Collector even though she was not included in the residents of Mathilmoola Colony.

In the Adalath held on 08/02/2020 it was decided to permit the remittance of the work deposit amount of 1,42,277/-for reconnecting the two services after obtaining consent from the revenue authorities. But now she has requested to reconnect the services on the expense of KSEBL as she is not able to pay the amount.

The Executive Engineer in Charge reported that the consumer is remitting current charges regularly and no dues pending in the case of domestic service connection. The current charge of the agricultural connection is being remitted by the Krishi Bhavan.

The District Collector ,Malappuram informed that there is no objection in restoring the supply in favour of Smt. Annakutty from their end.

The matter was placed before the Full Time Directors as per note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 12.07.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Nilambur for reconnecting the two service connections in favour of Smt,Annakutty (Con No 1167964003138&3139) after collecting the work deposit amount of Rs 1,42,277/-as decided in the Adalath held on 08/02/2020.

Orders are issued accordingly.


