#### ORDER

The Chief Engineer(C-I&CC) as per note read as 4<sup>th</sup> above reported that the Superintending Engineer, Siruvani Project Circle, Kerala Water Resources Department, Palakkad as per letter read as 2<sup>nd</sup> above had requested KSEBL for Rainfall and River discharge data for the preparation of Sustainable Alternative Solutions to Kuriarkutty Karappara Irrigation Project (SAKKIP).

Consequently the Deputy Chief Engineer, Investigation Circle, Thrissur as per letter read as 3rd above had intimated the Superintending Engineer, SAKKIP to remit Rs. 23,895/-as the required cost of the data fixed based on the rate fixed by the Government of Keraia as per letter read as 4 paper above for the supply of rainfall data for the developers in connection with the Small Hydro Electric Power Projects floated by Government of Kerala..

Subsequently the Superintending Engineer, SAKKIP as per the letter dated 14.06.2021 read as 2<sup>nd</sup> above has requested to waive the intimated data charges, stating that, the Sustainable Alternative Solutions to Kuriarkutty Karappara Irrigation Project is a joint venture project between KSEBL and Water Resource Department.

Accordingly the Chief Engineer(C-I&CC) as per letter read as 4<sup>th</sup> above has requested to sanction the Rain fall and River discharge data to the Superintending Engineer Siruvani Project Circle, Kerala Water Resources Department, Palakkad free of cost by considering the fact that, the Sustainable Alternative Solutions to Kuriarkutty Karappara Irrigation Project is a joint venture project between KSEBL and Water Resource Department.

The matter was placed before the Full Time Directors as per note read as 5<sup>th</sup> above. Having considered the matter, Full Time Directors in the meeting held on 12.07.2021, resolved to accord sanction to provide the requested Rain fall and River discharge data free of cost to the Superintending

Engineer, Siruvani Project Circle, Kerala Water Resources Department, Palakkad for the preparation of Sustainable Alternative Solutions to Kuriarkutty Karappara Irrigation Project by considering the fact that, the SAKKIP project is a joint venture project under consideration between KSEBL and Water Resource Department.

Orders are issued accordingly.
