## ORDER

The Deputy Chief Engineer, Electrical Circle,Kalpetta as per letter read as 1<sup>st</sup> above has reported that Sri.Muhammed Shafeer under Electrical Section Kalpetta had furnished an application for shifting the 11kV line passing over his property to facilitate construction of the house sanctioned by the Kalpetta Municipality. An estimate amounting to Rs 90993/- is required for shifting the 11kV line using 'A 'Pole for maintaining statutory clearance. The applicant is financially not in a position to remit the work deposit amount. It is reported as per letter read as 2<sup>nd</sup> above that the applicant belongs to a poor family with an annual income of Rs 36000/- as certified by the Village officer, Kalpetta. Also he belongs to BPL category and has produced the proof of the same.

The matter was placed before the Full Time Directors as per note read as 4<sup>th</sup>

Having considered the matter in detail, the Full Time Directors in the meeting held on 12.07.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kalpetta for the matter of carrying out the work of "shifting the 11kV OH line to facilitate construction of house sanctioned by Kalpetta Municipality" in favour of Sri.Muhammed Shafeer who belongs to BPL category under Electrical Section, Kalpetta by bearing cost of materials and 50% of labour charges by the Board and the balance 50% labour charges to be born by the applicant, considering the poor financial condition of the beneficiary, as a special case.

Orders are issued accordingly.
