ORDER

The Deputy Chief Engineer, Electrical Circle, Palakkad as per letter read as 1st above has reported that the complainant Smt.Indira a permanent resident of Nataraja Kounter colony under Electrical Section Kozhinjampara is a beneficiary of life mission project under Eruthempathy Grama Panchayath and belongs to BPL category as per the income certificate furnished.

At present the renovated house under Life Mission Project owned by the complainant is not maintaining statutory clearance with the 11kV Neelankachi feeder drawn through the area. A stop memo was issued to the complainant due to the safety issues. The work involves insertion of 2 nos 12 m A poles for maintaining statutory clearance. An estimate amounting to Rs 1,11,704/-is required. The complainant had registered complaint through on line in Sandhvana Sparsam Adalath conducted in February 2021 in Palakkad district requesting to waive the deposit amount,but she was unable to attend the adalath.

As per the BO read as 2nd above, "For applicants under BPL/SC/ST category, if electric line/posts are situated obstructing construction of house under "Life Mission Housing Scheme",for shifting the line to any other portion of the land or

along public path, to bear full cost of shifting by the Board if shifting is technically feasible."

The matter was placed before the Full Time Directors as per note read as 3rd above for a decision.

Having considered the matter in detail, the Full Time Directors in the meeting held on 12.07.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Palakkad to carry out the work of "maintaining statutory clearance by inserting 2 nos of 12 m A pole in the existing HT line to the renovated house under Life Mission Project in favour of Smt. Indira, NGP Colony" under Electrical Section, Kozhinjampara using Board's fund, considering the poor financial condition of the beneficiary and safety issues in the area, as a special case.

Orders are issued accordingly.
