ORDER

The Chief Engineer Distribution- North Malabar, Kannur as per letter read as 2nd above has forwarded two petitions received from Sri. Chathu V P(for line shifting) and Ms. Phathibi T P(withdrawal of excess bill due to earth leakage) at the Sandhvana Sparsham Adalath conducted on 2/02/2021 along with the decision of the Adalath Committee requesting sanction to implement the same .

The matter was placed before the Full Time Directors as per note read as 5th above for a decision.

Having considered the matter in detail, the Full Time Directors in the meeting held on 12.07.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kannur for the following.

1. For shifting the 11kV line in favour of Sri. Chathu V P under Electrical Section Parad on remitting 75% of the cost of shifting (balance 25% to be met by KSEBL) by the petitioner, considering his poor financial condition and that the petition was received in Sandhvana Sparsham Adalath 2021 .

2. To withdraw current bill of Rs 20,905/- raised during 3/2020 in favour of Smt.Phathibi T P(Consumer No 13599) who belongs to BPL category under Electrical Section Burnassery and collect normal charges based on previous average consumption as a special case considering that the petition was received in Sandhvana Sparsham Adalath 2021 and excess reading was due to earth leakage.

Orders are issued accordingly.


