ORDER

KSEBL has accorded Administrative Sanction as per B O read as 1st above for the construction of 110kV GIS in the compound of the existing 220kV Substation, Shornur with out disrupting the existing system for an amount of Rs.44.5 Cr. The work involves construction of 110kV GIS with four transformer bays, 10 feeder bays, two bus coupler bays, two bus sectionalizers and one capacitor bay in the compound of the existing 220kV Substation, Shornur. The Technical Sanction for this work was accorded by the Chief Engineer, Transmission North.

The subject work was e-tendered with PAC of Rs. 20.29 Cr excluding GST by the Chief Engineer, Transmission North and the bid was opened on 10.03.2021. Five bidders had participated in the tender and all the five Firms were pre qualified as per the decision of the PQ Committee held on 20.05.2021. The price bids were opened on 27.05.2021 and the lowest amount is quoted by M/s GE T&D Ltd, 19/1, GST Road, Pallavaram, Chennai with Rs. 18,62,55,593/- excl GST which is 8.1% below the estimated PAC. Negotiations were done at various levels, but the bidder M/s GE T&D Ltd informed their inability to reduce their quoted rate. The lowest quoted amount inclusive of GST @ 18% is Rs. 21,97,82,594/-. The Chief Engineer (Transmission North) as per letter read as 3rd above, has requested sanction to award the work to M/s. GE T&D Ltd at their quoted rate Rs.18,62,55,593/- excluding GST which is 8.1% below PAC. The remarks were sought from the Financial Adviser and it is recommended as per letter read as 5th above to award the subject work to the L1 bidder M/s GE T&D Ltd.

As per clause 3.1 (note 6) of Delegation of financial powers of Executive officers, for works above Rs.10 Crore, approval shall be obtained from the Full Time Directors before finalising the

tender. Hence the matter is placed before the Full Time Directors as per note read as 6th above for approval.

Having considered the matter in detail, the Full Time Directors in the meeting held on 12.07.2021,

Reolved to accord sanction to award the work "Design, manufacture, supply, erection, testing & commissioning of 110kV Gas Insulated Switchgear, supply, erection, testing & commissioning of control & protection panels for 110kV GIS as well as existing AIS 220kV bays, other indoor equipments, substation automation system for 110kV GIS as well as existing AIS 220kV bays and allied works at 220kV substation Shornur" to M/s GE T& D Ltd, Chennai at their quoted rate of Rs. 18,62,55,593/- (Rupees Eighteen Crore Sixty Two Lakh Fifty Five Thousand Five Hundred and Ninety Three only) + GST which is 8.1% below the estimated PAC

Orders are issued accordingly.
