ORDER

The KSEBL as per B.O read as 1st above had accorded administrative sanction for an amount of Rs 13.50 Crores for the setting up of three departmental PSC pole casting yards at land owned by KSEBL in Thiruvananthapuram (Pothencode), Kollam (Kundara), Idukki (Sengulam) and for the maintenance of Choolissery yard and Mangattuparamba departmental yard. KSEBL also accorded sanction to entrust the above works with the Chief Engineer (Civil Construction) South.

The suitability of land available at Sengulam for establishing pole casting yard was examined and found that there exists steep slope for the access to the area and hence transportation of poles after casting will be difficult through the sharp curves in the access road. Suitable land is available at Moolamattom and this can be developed with much less cost to pole casting yard and transportation will be much easier.

The Chief Engineer as per note read as 2nd above has requested sanction to entrust Executive Engineer, Civil Division, Thiruvananthapuram for the execution of the setting up of pole casting yard at Pothencode, the Executive Engineer, Investigation Division, Kottarakkara for the execution of the setting up of pole casting yard at Kundara and the Project Manager, Ladrum & Marmala Small HEP for setting up of Pole casting yard at Moolamattom

The above matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 12.07.2021

1. Resolved to accord sanction to establish the proposed pole casting yard in Idukki at Moolamattom instead of Sengulam as decided vide B.O (FTD) No. 665/2020 D (G-E & SCM/GL/2020-21) dated 05.11.2020

2.Further resolved to authorize the Executive Engineer, Civil Division, Thiruvananthapuram for the execution of the setting up of pole casting yard at Pothencode, Executive Engineer, Investigation Division, Kottarakkara for the execution of the setting up of pole casting yard at Kundara and the Project Manager, Ladrum & Marmala Small HEP for the execution of setting up of Pole casting yard at Moolamattom.
