#### **ORDER**

The KSEBL and the Government of Kerala have accorded Administrative sanction for the implementation of Mankulam Hydro Electric Project (40 MW) in the Mankulam Village in Devikulam Taluk of Idukki District.

The land acquisition for the implementation of Mankulam HEP is in the final stage. Of the total of 80.013 ha of land required for the project, 72.79 ha has been acquired from around 300 land holders. The balance land to be acquired is about 7.34 ha as detailed below.

Of the balance 5.6 ha patta land to be acquired, 0.4347 ha is required for the proposed dam structures and the remaining is in the submergible area. Out of 1.74 ha of non patta land to be acquired, 0.2708 ha are in the site of the proposed dam structures and the remaining is in the submergible area.

The anticipated revised estimate is Rs. 310 Crore (Excluding GST), against the sanctioned amount of Rs. 161.952 Crore provided in the administrative sanction dated 4.08.2009, thus necessitating revised administrative sanction for the revised cost.

During the meeting convened by the Hon'ble Minister for Power held on 16.06.2021, it was directed to invite the tender for the project within 90 days.

The Chief Engineer(Civil- Investigation & Construction Central) has requested to accord sanction for inviting tender for executing the civil part of the Mankulam HE Project, based on the existing mode of Contract System as provided in the Board Order read as 3<sup>rd</sup> paper above.

The proposal was placed before the Full Time Directors as per note read as 5<sup>th</sup> paper above. Having considered the matter in detail, the Full Time Directors in its meeting held on, 12.07.2021, resolved to direct the Chief Engineer (Civil- Investigation & Construction Central) to expedite the land acquisition process. Further resolved to accord sanction to the Chief Engineer (Civil- Investigation & Construction Central) to invite tender for executing the Civil works of the Mankulam HEP on Percentage Rate Contract System, subject to the condition that work order shall be issued only after ensuring the availability of land.

The Chief Engineer(Civil- Investigation & Construction Central) shall take further necessary action in this regard.

Orders are issued accordingly.
