ORDER

For the implementation of Filament Free Kerala Programme, Purchase Orders for supplying One Crore 9W LED bulbs were issued to M/s Crompton Greaves Consumer Electricals Ltd and M/s H.Q. Lamps Manufacturing Co. Pvt. Ltd on 28.10.2020. The Additional Purchase Orders for procuring 25% additional quantity (25 Lakh LED bulbs) have been issued to both the firms on 24.6.2021. The agreements for these have to be executed, after producing Security Deposit (10% contract value) as Bank Guarantee.

M/s Crompton Greaves as per letter read as 6th above has informed that they have accepted the additional purchase order and requested to reduce the Security Deposit to be produced from 10% to 3% of the contract value based on the relaxations given by the Government of India and Government of Kerala, on account of COVID -19 pandemic.

The matter was placed before the Full Time Directors for decision, as per the note read as 7th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 12.7.2021,

Resolved to reduce the Security Deposit to be submitted as Bank Guarantee for the purchase of 25% additional quantity (25 Lakh) of 9W LED bulbs under Filament Free Kerala programme by M/s Crompton Greaves Consumer Electricals Ltd and M/s H.Q. Lamps Manufacturing Co. Pvt. Ltd from 10% to 6 % of the contract value, as decided by the Board.

Orders are issued accordingly.
