### ORDER

The Deputy Chief Engineer ,Electrical Circle,Kasaragod as per letter read as 1<sup>st</sup> above reported that even after re tendering the work two times, only a single bid was received for the Dyuthi work of 'Pole erection and standardization for converting 11kV OH portion KEL feeder to ABC' under Electrical Section Kasaragod with PAC of ₹14,41,233/-. Sri P V Abdul Majeed, P.V House, Kadoor, Kannur, the lone bidder quoted for the work with a rate of 1.1% below the estimate rate ie. ₹14,25,379/-.

Since there was not enough participation in the 3 tenders for the work mentioned , the Deputy Chief Engineer has requested sanction, being single tender, for carrying out the work at 1.1% below estimate rate.

The matter was placed before the Full Time Directors as per note read as 4<sup>th</sup> above.

Having examined the matter in detail, the Full Time Directors in the meeting held on 02.07.2021 resolved to accord sanction to the Deputy Chief Engineer,

Electrical Circle, Kasaragod for accepting the single bid for the work of 'Pole erection and standardisation for converting 11kV OH portion KEL feeder to ABC' under Electrical Section Kasaragod on re-tendering, and for awarding the said work with a quoted rate of 1.1% below estimate rate ie. ₹ 14,25,379/-to Sri.P.V.Abdul Majeed, taking into account the limited time available for execution of PMU works.

Orders are issued accordingly.


