ORDER

The Chief Engineer (Generation & PED) has reported that Adyanpara SHEP was commissioned on 03-09-2015 and is located in a remote area. At present the station has no internet connection and the Mobile signal power is also very low in this area. The Internet connection is essential for a power house to send and receive office related e- mails and uploading of generation data etc. in a time bound manner and sharing of half hourly MWh, MW and MVAR (Via Dropbox) with State Load Despatch Centre.

As per B.O read as 1st above, sanction was accorded for replacing BSNL Broad Band connection at various KSEBL offices with BSNL FTTH (Fiber to the Home) connection. It is also reported that for availing BSNL FTTH connection at Adyanpara, cabling for a length of 3 km is required and as informed by the BSNL Authorities, the expenditure may be around Rs. 3 lakh. Hence, the Chief Engineer (Generation & PED) has submitted an estimate for availing internet connection through private cable TV operator. As the private cable network is not reliable, it was directed to explore the feasibility of availing BSNL Internet connection through OFC or by providing BSNL tower.

The Chief Engineer (Generation & PED) as per letter dated 25-06-2021, has reported that BSNL authorities were contacted and it was informed that the internet connection can be provided through wireless RF link. Accordingly, based on the proposal of Quadtri Technologies Pvt. Ltd, Kochi, the Channel partner and system integrator of BSNL, an estimate amounting to Rs. 85,287/- has been prepared and requested sanction for availing Internet connection.

The matter was placed before the Full Time Directors as per Note read as 4th above. Having considered the matter in detail, the Full Time Directors in the meeting held on 02-07-2021 resolved to accord sanction to the Chief Engineer (Gen.& PED) for availing Internet connection at Adyanpara SHEP through Quadtri Technologies Pvt. Ltd, Kochi, Channel partner and system integrator of BSNL at an estimated amount of Rs. 85,287/- which includes monthly charges of Rs. 1507/-.

Orders are issued accordingly.
