ORDER

The Deputy Chief Engineer,Electrical Circle, Shoranur as per letter read as 2nd above has forwarded a petition in respect of Sri.Prabhakaran V P,Vizhakadu Panikathu House,Kailyad,Shoranur(Adalath No.3) received at the Sandhvana Sparsham Adalath conducted on 09/02/2021& 11/02/2021 along with the decision of the Adalath Committee requesting sanction to implement the same .

Sri.Prabhakaran V P under Electrical Section Vallapuzha has requested to shift the LT poles and lines passing through his property. The estimate amount for shifting the lines and poles is Rs 38617/-including GST.

The Deputy Chief Engineer,Electrical Circle, Shoranur reported as per letter read as 3rd above that the consumer belongs to APL category with connected load 3572 watts and recommended that this line can be shifted to the proposed route on work deposit basis.

The matter was placed before the Full Time Directors as per note read as 4th above.

Having examined the matter in detail, the Full Time Directors in the meeting held on 24.06.2021 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Shoranur to shift the LT poles and lines passing through the property of Sri.Prabhakaran V P under Electrical Section Vallapuzha on remitting 75% of the cost of shifting (balance 25% to be met by KSEBL), considering that the petition was received in Sandhvana Sparsham Adalath 2021 .

Orders are issued accordingly.
