ORDER

The TransGrid TC Division, Kozhikode was formed as per BO read as 2nd above with Head Quarters at Kozhikode after shifting the place of the O/o the Project Manager, Kattakkada on completion of 220kV Substation, Kattakkada and its associated lines. The TransGrid Kozhikode Division is entrusted with the construction of 220kV Gas Insulated Substations at Kunnamangalam & Thalassery, execution of NRHTLS project, North Malabar Line Strengthening Package (NMLP), Kolathunad Line Strengthening Package (KLSP), 400kV line works under Northern Green Corridor Project etc.

The NRHTLS project was completed and the construction of 220kV GIS at Kunnamangalam is in its final testing and commissioning stage. The other ongoing works under Kozhikode Division are, Construction of 220/110kV MCMV (Multi Circuit Multi Voltage) line from Mundayad to Thalassery under NMLP-A package, Construction of 220 GIS at Thalassery under GIS-3 package, Construction of 220/110kV MCMV line from Kanjirode to Mundayad under KLSP-A package, Construction of 220/110kV MCMV line from Mundayad to Mylatty under KLSP-B package and Construction of 400kV DC line (125 km) from Payyampilly to Karindalam under NGPC.

KSEBL as per BO read as 1st above, has accorded sanction to approve the organization structure of the TransGrid project by redeployment. The projects Progressing/Starting under TransGrid 2017-18 and relevant Divisions & Subdivisions as per Annexure 3 of this BO, is inclusive of the places already sanctioned and is the minimum required to start the most urgent work so as to utilize the man power effectively to the extent possible. It is also specified in this BO that, on completion of each work the places can be shifted to the next site or can be deployed elsewhere on completion of the entire project.

The Chief Engineer, TransGrid as per note read as 3rd above, has reported that the substation and line works around Kozhikode are almost completed and it is suggested to shift the TC Division Kozhikode to Kannur, being the convenient location to carry out the balance works.

In view of the above the D(T&SO) also, recommended to shift the Head Quarters of TransGrid TC Division, Kozhikode to Kannur for executing the works under Wayanad, Kannur & Kasaragod districts and to rename the division as TransGrid TC Division, Kannur after the commissioning and handing over of 220kV GIS Substation, Kunnamangalam.

The matter was placed before the Full Time Directors for sanction as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 24.06.2021,

Resolved to accord sanction to shift the HQ of TransGrid TC Division, Kozhikode to Kannur for executing the works under Wayanad, Kannur & Kasaragod districts after the commissioning and handing over of 220kV Substation, Kunnamangalam.

Further resolved to accord sanction to rename the TransGrid TC Division, Kozhikode as TransGrid TC Division, Kannur.

Orders are issued accordingly.
