ORDER

The Deputy Chief Engineer,Electrical Circle, Shoranur as per letter read as 2nd above has forwarded the following petitions received at the Sandhvana Sparsham Adalath conducted on 09/02/2021& 11/02/2021 along with the decision of the Adalath Committee requesting sanction to implement the same .

1. Sri.K.K.Gopinathan and 3 others, Kothappurathu House, Kallipadam P O, Shoranur (Adalath No.2).

2. Smt.Murukeswari,Lakshamveedu Colony,Thachampadi,Pudur (Adalath No.6).

Sri.K.K.Gopinathan and 3 others under Electrical Section Shoranur have requested for shifting of 11kV line to a suitable location so that the line crossing their property would be shifted to the roadside.

The Adalath decision noted in the above case is that the Deputy Chief Engineer, Electrical Circle, Shoranur shall take action to issue 25% concession to carry out the work.

The Deputy Chief Engineer, Electrical Circle, Shoranur as per letter read as 3rd above has reported that the consumer belongs to APL category with connected load 5428 w and recommended that by shifting the line it is more safe in operation of line.

The second petitioner Smt. Murukeswari has requested to shift the LT post and line passing near to her house under Electrical Section Kottathara.

The Adalath decision noted in the above case is that the Deputy Chief Engineer, Electrical Circle, Shoranur shall take action to issue 50% concession to carry out the work

The Deputy Chief Engineer, Electrical Circle, Shoranur reported as per letter read as 3rd above that the consumer belongs to BPL category (Scheduled Tribe) with connected load 180w and recommended for the Adalath decision.

The matter was placed before the Full Time Directors as per note read as 4th above.

Having examined the matter in detail, the Full Time Directors in the meeting held on 24.06.2021 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Shoranur for the following.

1. To shift the 11 kV line to the road side as per the request of Sri.K.K.Gopinathan and 3 others under Electrical Section Shoranur on remitting 75% of the cost of shifting (balance 25% to be met by KSEBL), considering that the petition was received in Sandhvana Sparsham Adalath 2021 and that the proposal is beneficial to KSEBL .
2. To shift the LT post and line passing near to the property of Smt. Murukeswari under Electrical Section Kottathara on 50% concession for carrying out the work, considering that the applicant belongs to BPL category and the petition was received in Sandhvana Sparsham Adalath 2021.

Orders are issued accordingly.
