ABSTRACT

Request for temporary disconnection of HT supply and providing new LT connection by M/s HPCL (LCN:15/1535) under Electrical Section Eranhikkal - Sanctioned - Orders issued.

ORDER

The Executive Engineer in charge, Electrical Circle, Kozhikode had reported as per letter read as 1st above that M/s HPCL,Elathur (LCN:15/1535) an HT consumer under Electrical Section Eranhikkal has requested for temporary disconnection of the HT supply and for providing new LT connection. The APTS, Kozhikode had conducted inspection in the premises of M/s HPCL on 17.07.2020 and detected load of 314.59 kW which was in excess of the sanctioned connected load and also maximum demand found exceeded. In this connection M/s HPCL was served with a final assessment order under section 126 of Electricity Act 2003,directing the company to remit Rs 72,46,028/-. M/s HPCL filed appeal petition before Hon'ble High Court of Kerala and the Hon'ble High court vide judgement dated 03.11.2020 directed the petitioner that,"if the petitioner pays 50% of Rs 49,36,036/-(ie. demand charges) along with appeal under section 127,the said appeal shall be treated as a valid appeal which Appellate Authority shall then proceed to consider on merits after hearing the petitioner. The petitioner shall prefer the appeal along with appeal fee within two

weeks from the date of receipt of the copy of the judgment. On the petitioner preferring the appeal as aforesaid, the recovery of the balance charges as per proceedings dated 05.10.2020 shall be kept in abeyance till such time as orders are passed in the appeal by the appellate authority and the order communicated to the petitioner”.

Accordingly M/s HPCL remitted Rs 24,68,018/-(50% of Rs 49,36,036/-) and filed an appeal petition before the Appellate Authority (appeal No.88/2020). The appeal is pending.

Now M/s HPCL has requested for temporary disconnection of HT supply for executing the revamp project to meet the operational safety norms as per Oil Industry Safety Directorate and new LT connection with connected load of 35 kW for maintaining the office load, UPS and other utilities. They agreed for payment of fixed charges for HT service connection during the disconnection period.

As per the report from the Special Officer Revenue, M/s HPCL Elathur, (LCN:15/1535) under Electrical Section Eranhikkal is having Rs 2,52,070/- as security deposit and does not have any pending current charge arrear for realization of HT service connection.

Hence an undertaking shall be obtained from the consumer in stamp paper regarding compliance of decision of the Appellate Authority and payment to KSEBL . .

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having examined the matter in detail, the Full Time Directors in the meeting held on 24.06.2021 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kozhikode to process the request for temporary disconnection of HT supply and request for providing new LT connection by M/s HPCL Elathur, (LCN:15/1535) under Electrical Section Eranhikkal as an appeal of the consumer is under consideration of Appellate Authority and also to ensure the payment of fixed charges for HT service connection during the disconnection period.

Further resolved that an undertaking shall be obtained in stamp paper regarding compliance of decision of Appellate Authority and payment of arrears to KSEBL .

Orders are issued accordingly.
