**ORDER**

Based on the decision of the Full Time Directors dated 21.06.2021, M/s Malabar Waste Management Pvt Ltd was intimated as per letter read as 6<sup>th</sup> above that KSEBL is willing to enter into PPA for the Waste to Energy plant at Njaliamparambu, Kozhikkode at the levelized tariff of **Rs. 6.81/unit** without the benefit of accelerated depreciation provisionally approved by the Hon'ble KSERC in the Order read as 3<sup>rd</sup> above. The PPA for the project was amended accordingly and also incorporating the amendments, which the firm had proposed in their letter dated 10.05.2021.

The Chief Engineer (Commercial & Tariff), in the note read as 7<sup>th</sup> above, has suggested to amend PPA for the 6MW Waste to Energy Project at Kozhikkode. It was also suggested to authorize Chief Engineer (Commercial & Tariff) to initial the PPA and forward the PPA to M/s Malabar Waste Management Ltd for initialing from their side and submitting before the KSERC for approval. The proposed amendments and the amended PPA are attached

In view of the above, this matter was submitted before Full Time Directors, through circulation for decision.

Having considered the matter in detail, the Full Time Directors

- Resolved to approve the amended PPA
- Further resolved to authorize the Chief Engineer (Commercial & Tariff) to initial the amended PPA.
- Further resolved to forward the initialled PPA to M/s Malabar Waste Management Ltd for initial and subsequent submission before the KSERC.
