ORDER

As per the letters read as 1st above, the Chief Engineer (Distribution South), Thiruvananthapuram has reported that Electrical Section, Erumely is presently functioning in an old rented building in Erumely Town. Much difficulty is experienced by the staff during working hours due to limited space in the building. There is no adequate space for the free movement of the consumers and sufficient space is not available for parking of vehicles and storage of materials. The Director (Transmission & System Operation) had accorded sanction on 22/05/2020 to hand over 20 cents of land available in the premises of 110 kV Substation, Erumely to the Distribution wing for the construction of Electrical Section, Erumely.

The Chief Engineer (Distribution South), Thiruvananthapuram has proposed to construct a double storeyed building having a revised total plinth area of 188 m² [Ground floor – 108 m² and first floor – 80 m²] for accommodating Electrical Section, Erumely in the land earmarked to Distribution wing. Total expenditure anticipated for the above proposal is comes to ₹80 lakh.

In the above circumstances, the Chief Engineer (Distribution South), Thiruvananthapuram requested approval of plan and Administrative Sanction for an amount of ₹80 lakh for the construction of building for accommodating Electrical Section, Erumely.

The matter was placed before the Full Time Directors as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 24/06/2021, resolved to accord sanction for constructing a double storeyed building for accommodating Electrical Section, Erumely in the 20 cents of land earmarked in the premises of 110 kV Substation, Erumely. Further resolved to approve the plan for the construction of the building having a total plinth area of 188 m² [Ground floor – 108 m² and first floor – 80 m²] by
