## ABSTRACT

Hiring a jeep /equivalent vehicle with driver for the use of Line Construction Section (LC Section) Mananthavady under Transmission Circle, Kozhikode for a period of one year – Sanctioned - orders issued.

## ORDER

The upgradation and conversion of 18.9km 66kV Kaniyambetta -Mananthavady SC line to 110kV DC is entrusted with Line Construction Section Ambalavayal. The Chief Engineer, Transmission North has accorded sanction to rename the Line Construction Section, Ambalavayal as **Line Construction Section, Mananthavady** and to shift the head quarter to 66kV Substation, Anjukunnu from Ambalavayal, for the efficient and timely completion of the project. Also, there is no vehicle attached to Line Construction Section, Mananthavady (formerly LC Section Amabalavayal). It is also reported that, the upgradation of Mananthavady line is in progress and foundation of 5 Number of tower are completed. Tree marking is progressing considerably. The works under LC Section, Mananthavady are distributed in the terrain which is inhospitable and hilly. Moreover, no public conveyance is available in this pandemic situation of COVID19. In this context, a vehicle with driver is exigent for carrying out this work under LC Section, Mananthavady. The annual financial commitment in this regard will be Rs.4,00,000/-. This includes hire charges @ Rs. 17/km for 1500 (Rs.3,06,000),10 % hill track allowance (Rs.30,600/-), contingency ( Rs.2,812/- ) and 18%GST (Rs.60,588/-).

The works under LC Section, Mananthavady are distributed in the terrain which is inhospitable and hilly. Moreover, no public conveyance is available in this pandemic situation of COVID19. Hence a vehicle with driver is highly essential for the smooth functioning of the works.

In this regard, the Chief Engineer, Transmission North has requested sanction for hiring a vehicle (diesel jeep/ equivalent) with driver for the use of Line Construction Section, Mananthavady with a monthly km ceiling of 1500 km for a period of one year or till the completion of the upgradation and conversion of 18.9 km 66kV Kaniyambetta -Mananthavady SC line to 110kV DC line, whichever is earlier.

The matter was placed before Full Time Directors as per note read as 4<sup>th</sup> above. Having considered the matter in detail, the Full Time Directors in the meeting held on 17.06.2021,

Resolved to accord sanction for hiring a vehicle (diesel jeep/equivalent vehicle) with driver on monthly contract basis for the use of Line Construction Section, Mananthavady with a monthly kilometer ceiling of 1500 km for a period of one year or till the completion of the upgradation and conversion of 18.9 km 66kV Kaniyambetta -Mananthavady SC line to 110kV DC line whichever is earlier. The average annual financial commitment to KSEBL in this regard will be Rs. 4,00,000/- (incl GST).
