### ORDER

For the installation of Electric Vehicle Charging Stations (EVCS),sanction was accorded to a list of field level Executive Engineers under Transmission and Distribution wing as “Engineer in charge” (EIC) as per Board order read as 1<sup>st</sup> above by considering the feasibility/ sustainability in terms of land ownership and efficacy and efficiency of work execution at the field. The Engineer in charge is entrusted with the responsibility of collecting consent of land owners for the establishment of EVCS under the FAME II scheme and supervision of EV Charging Station installation works under Central and State Scheme.

Subsequently some of the Engineers in charge have reported the jurisdictional difficulties in executing the project assigned to them ,hence new EIC’s have to be nominated. Similarly some of the sites recommended as per the BO read ,later were found to be non feasible for setting up of EVCS and hence new sites have to be proposed.

The above matter was brought to the notice of the Full Time Directors as per note read as 3<sup>rd</sup> above incorporating a supplementary list of Engineer in charge to overcome the jurisdictional issues as Annexure I and a list of newly proposed locations against the non feasible locations and corresponding Engineer in Charge as Annexure II. Having

considered the above, the Full Time Directors in its meeting held on 11.6.2021, resolved to approve the following

1. The proposed new locations as per the Annexure II attached.
2. The proposed additional list of "Engineer in Charge" as per the 'Annexure I & II' attached

The BO read as 1<sup>st</sup> above stands modified to the above extent.


