ORDER

The Chief Engineer, Transmission South as per note read 2nd above has informed that, the present contract of the hired diesel jeep having cubic capacity 1500 and above with driver for the use of Transmission Sub Division, Perumbavoor was expired on 16.04.2021 and the Deputy Chief Engineer, Transmission Circle, Thodupuzha has invited fresh competitive tenders two times for the same. In the first time no tender forms were sold. Then the second time three tenders were received and out of which Sri. Sajith V.R is the lowest tenderer and his quoted amount is Rs.30,150/month (Rs.20.10/km for first 1500km and Rs.20/km every km beyond 1500km).

The Chief Engineer, Transmission South, has reported that, considering the present hike in price of fuel and maintenance cost, the chance of getting a better offer on re-tender seems to be remote. Further it is informed that the availability of jeep on hired basis is very few because such vehicles having taxi permit is rare nowadays.

In this regard, the Chief Engineer, Transmission South has requested sanction to award the work of 'Hiring a diesel jeep having cubic capacity 1500 and above with driver for the use of Transmission Sub Division, Perumbavoor for a period of one year to the lowest bidder Sri. Sajith V.R Vattakkaithayil (H), Eananalloore P.O, Kakkattoor, Perumbavoor, Ernakulam at his quoted amount of Rs.30,150/month (ie Rs.20.10/km upto 1500km and Rs.20/km every km beyond 1500km).

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 11.06.2021

Resolved to accord sanction for hiring a diesel jeep having cubic capacity 1500 and above with driver for the use of Transmission Sub Division, Perumbavoor with a monthly kilometer ceiling

of 1500km for a period of one year to the lowest tenderer Sri. Sajith V.R Vattakaithayil (H), Eananallore P.O, Kakkatoor, Perumbavoor, Ernakulam at his offered amount of Rs.30,150/month (ie Rs.20.10/km upto 1500km and Rs.20/km every km beyond 1500km). The additional financial commitment due to tender excess comes to Rs. 25,200/- for one year
