ORDER

As per the Office Order read as 1st above, sanction was accorded to constitute a Committee for the design review of drawings and documents for the balance E&M works of Thottiyar (1X30+1X10) MW HEP including the work of Supply, erection, testing and commissioning of Governor, Excitation, DCS and Protection panels, with Sri. Jayarajan C. N., Deputy Chief Engineer, O/o the Chief Engineer (Transgrid), Shoranur along with 6 others as members. Subsequently, as per B.O read as 2nd above, sanction was accorded to constitute a Technical Committee for the RMU works of Kuttiyadi HEP with Sri. Jayarajan C.N, Deputy Chief Engineer as Chairman along with 18 other members.

The Chief Engineer (Generation & PED) as per letter read as 3rd above has reported that Sri. Jayarajan C.N, Deputy Chief Engineer, O/o the Chief Engineer (Transgrid), Shoranur, who is a member of both the committees has retired on superannuation on 31.05.2021. Sri. C.N.Jayarajan has profound experience in matters relating to protection and automation, excitation and governing systems and his presence in the above mentioned committees is most essential for the early completion of the projects. The technical committees are held both internally and with contractors for discussing various issues and Sri. Jayarajan C.N has immense role in sorting out the same. It is further reported that Sri. Jayarajan C.N, has agreed to provide his service voluntarily without any cost to the KSEBL and with immense pleasure. Considering the above, the Chief Engineer (Generation & PED) has requested sanction for retaining Sri. C.N.Jayarajan, Deputy Chief Engineer (Rtd.) in both the above Committees without any additional financial commitment to KSEBL.

The matter was placed before the Full Time Directors as per Note read as 4th above. Having considered the matter in detail, the Full Time Directors in the meeting held on 11-06-2021 resolved to accord sanction for retaining Sri. C.N Jayarajan, Deputy Chief Engineer (Rtd.) in the Committees constituted for balance E&M works of Thottiyar (1X30+1X10) MW HEP and RMU works of Kuttiyadi HEP as per Orders dated 02-02-2021 and 22-04-2021, since it is a voluntary service.
