## **ORDER**

Sanction was accorded as per B.O read as 1<sup>st</sup> above, to permit M/s TELK, Angamaly to use the 60MT Weigh Bridge owned by KSEBL and installed at the premises of B&S Division, Angamaly subject to the terms and conditions stipulated in the order & the validity of the same was one year from the date of the order.

Later, the permission was extended for subsequent years with the newly proposed rates and with an additional condition that service tax, if any, shall be borne by M/s.TELK. The latest extension of the weighment facility was permitted to M/s. TELK as per B.O read 2 above for a period of one year with effect from 05.05.2020 subject to the existing terms and conditions but at the revised rates contained therein with applicable GST.

Now the Chief Engineer (Civil Construction) South as per letter read as 3<sup>rd</sup> above reported that the permitted period as per B.O dated 23.03.2020 would expire on 04.05.2021 and M/s. TELK has requested to extend this facility for one more year i.e. from 05.05.2021 under the same rates, terms and conditions. The Chief Engineer has recommended to accord sanction for extending the facility permitted to M/S. TELK with the existing terms and conditions but with an increase of 10% in the existing rate due to the hike in the price of consumables and other connected services with applicable GST.

Having considered the matter in detail as per note read as 4<sup>th</sup> paper above, the Full Time Directors in the meeting held on 11.06.2021 resolved to accord sanction for extending the weighment facility permitted to M/s. TELK for using the 60 MT Weigh Bridge

owned by KSEB Ltd, installed at the premises of B & S Division, Angamaly for a further period of one year with effect from 05.05.2021 subject to the existing terms and conditions stipulated in B.O read 2 above but at the revised rates as detailed below plus applicable GST.
