ORDER

As per the Board Order read as 1st above, sanction was accorded for awarding an honorarium of Rs.1500/- per week to the doctor of Seethathode Public Health Centre for his additional service at Moozhiyar dispensary for one day (limited to 6 hours per week).

The Chief Engineer (Generation & PED) as per letter read as 4th above has reported that as per the orders of the District Medical Officer, Pathanamthitta the doctor is now being engaged at the dispensary for two days per week and he is performing to the best of his ability in rendering the services. The doctor has requested for a hike in his remuneration from the existing rate of Rs.1500/- to Rs.3000/- per day.

Subsequently, as per the Government Order read as 2nd above, orders are issued enhancing the rates of daily workers/contract workers and the same has been adopted in KSEBL as per Board Order read as 3rd above. In the above mentioned Board Order, the enhancement of rates for only five categories viz. Security, Driver, Data Entry Operator, Cleaner and Helper was specifically mentioned, wherein the wage revision of the Medical Officer is not included.

Considering the above, the Chief Engineer (Generation & PED) requested sanction for enhancing the applicable rate for engaging Medical Officer at the KSEBL dispensary at Moozhiyar by adopting the rate revision as per above G.O(Annexure – Category XII daily wages amounting to Rs.1960/- per day) and for engaging the Medical Officer for two days per week (limited to 6 hours per day) at the KSEBL dispensary at Moozhiyar.

The matter was placed before the Full Time Directors as per Note read as 5th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 11-06-2021 resolved to accord sanction to allow an amount of Rs.1500/-per day to the Medical Officer engaged at the KSEBL dispensary at Moozhiyar either as honorarium or as a fixed amount for meeting his travelling expenses.

Orders are issued accordingly.
