ORDER

The General Hospital, Ernakulam bearing Con. Code 30/3989 is a High Tension consumer under the jurisdiction of Electrical Circle, Ernakulam. The consumer has not remitted the current charge from 04/2014 onwards. KSEBL sanctioned order to clear the dues under OTS Scheme 2019. Being a Government Hospital and due to the lack of fund allotment from the Government, they failed to remit the arrear within the time limit. Due to the continuous intervention the consumer remitted ₹ 8,72,82,703/- on 25.03.2021 and submitted an application for consideration under One Time Settlement 2021 vide order 1st above. The matter was placed before the Full Time Directors as per paper read 3rd above

Having considered the matter in detail, the Full Time Directors, in its meeting held on 11.06.2021 resolved to accord sanction for the settlement of

arrears in respect of General Hospital, Ernakulam (LCN 30/3989) under One Time Settlement Scheme 2021, considering that the consumer is a Government institution.
