Effective flood management – Hiring a jeep for managing the monsoon floods in Kakki reservoir-Sanctioned- Orders issued.

ORDER

The Dam Safety Sub Division, Moozhiar manages the operation and maintenance of Anathode, Kakki and Upper Moozhiyar dams of Sabarigiri Hydro Electric Project and associated structures. The dams are located in dense forest and the farthest one is about 30 km away from the Sub Division Office. The spillway gates of Kakki reservoir is located in Anathode dam. The spilling is to be done regularly for maintaining the rule levels during monsoon season. Further, earth slips along the road to Anathode dam are common and in the last year such events occurred several times. The communication failure is also a major issue during monsoon.

The Chief Engineer(Civil-Dam Safety &DRIP) as per note read as 1st above has reported that there is only one hired jeep attached to the Dam Safety Sub Division, Moozhiar for the movement of Assistant Executive Engineer, Assistant Engineers and other field Staff entrusted with the monitoring of safety and security of various installations of Sabarigiri Hydro Electric Project. The Chief Engineer has requested one more vehicle for the smooth movement of the officers in charge of the dams in connection with monsoon activities for 5 months period from 7/2021 to 11/2021. It is also reported that the approximate expenditure for hiring a jeep will be about Rs 33000/ month (1750 Km / month) and the total expenditure for 5 months comes to Rs. 1,65,000/-.

The matter was placed before the Full Time Directors as per note read as 2nd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 11.06.2021 resolved to accord sanction to the Chief Engineer(Civil-Dam Safety &DRIP) for hiring a jeep for the period from July to November 2021 for better management of activities in the monsoon season with a monthly ceiling of 1750 km.

Orders are issued accordingly.
