Shifting of HT/LT poles along Thalassery-Kodiyeri road renovation work under Electrical Section, Kodiyeri along with road widening work as requested by the PWD - Sanctioned – Orders issued

ORDER

KSEBL had accorded sanction as per BO read 1 above to the Deputy Chief Engineer, Electrical Circle, Kannur to carry out the work of shifting of HT/LT poles along Thalassery - Kodiyeri road under Electrical Section, Kodiyeri at an estimate amount of ₹18,50,000 in connection with PWD road widening works, as requested by the PWD, based on an undertaking to the effect that the estimate amount will be remitted to KSEBL at the earliest, as a special case.

The Executive Engineer, Electrical Division, Thalassery, read as 2nd above, has now reported that

PWD had given application for the shifting of utilities in 4 phases for 1.35 km, 0.945 km, 0.15 km and 1 km respectively and 95% of the works in 1st phase have been completed so far in compliance with the BO read as 1st above.

The Assistant Engineer, PWD Roads Section, Thalassery has now requested time extension for payment towards the entire works in four phases which amounts to ₹38,66,471/- (i.e. ₹18,50,000 + ₹13,43,126 + ₹49,075 + ₹6,24,270 = ₹38,66,471), assuring that the entire

The subject work involves shifting of the utilities along the main road to the reputed Malabar Cancer Centre, a Covid hospital, and there is pressure from the public and people's representatives for early completion of road work before the monsoon showers.

PWD has not till date remitted the estimate amount of ₹18,50,000/- despite constant follow-up.

The Deputy Chief Engineer, Electrical Circle, Kannur, read as 4th above has sought directions on the request from PWD for getting the subject work (for which the estimate amount is pending payment) completed and for granting time for payment of the estimate amount (totaling to ₹38,66,471/-, including the already pending amount of ₹18,50,000/- for the almost completed first phase work).

The Deputy Chief Engineer has also called attention to another amount of ₹11,85,000/- pending from PWD for the completed work under Electrical Section Pinarayi. (Parappuram - Meloorkavu).

The matter was placed before the Full Time Directors as per note read as 5th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 11/06/2021, resolved to accord sanction to Deputy Chief Engineer, Electrical Circle, Kannur, to carry out the entire work of shifting of HT/LT poles along Thalassery-Kodiyeri road in connection with the PWD road widening work, under Electrical Section, Kodiyeri for an estimate amount of ₹38,66,471/- (which is pending payment from PWD) as requested by the PWD, after getting an undertaking from PWD that the amount will be remitted to KSEBL at the earliest, considering that the subject work is along the main road to the Malabar Cancer Centre which is a Covid hospital, and also considering that the early completion of road works before the monsoon showers is essential.

Further resolved to direct the Deputy Chief Engineer, Electrical Circle, Kannur to ensure by constant follow up that the above amount of ₹38,66,471/- as well as the amount of ₹11,85,500/ which is the pending payment from PWD for the already completed work Parappuram Meloorkavu under Electrical Section, Pinarayi, are remitted at the earliest.
