<u>ORDER</u>

The Executive Engineer, Electrical Division, Tirurangadi as per letter read as 4th above reported that Sri. Rajesh, S/o Subrahmanian, Chatham Kandathil (H), Kadalundi Nagaram Malappuram has applied for service connection at Electrical Section Vallikkunnu under BPL category. Construction of 237 meters of LT single phase two wire line with 6 nos of poles and 25 m of WP portion single phase OH line with stay amounting to Rs 90,490/- is required for effecting the single phase service connection.

The applicant furnished Income certificate dated 10.07.2019 issued by the Special Village Officer, Ariyallur Village Office stating that their annual family income is below Rs 50000/-. Free connection for BPL OH category is admissible up to 200 m Over Head. The estimated length is beyond the stipulated OH line length for free of cost connection under BPL category. The connected load of the premises is 460 watts.

The applicant belongs to poor family under BPL category and his daughter is studying in eighth standard and electric connection is very essential for attending on line classes and now his daughter is depending one Anganvadi in the near by locality for on line classes As per BO read 1 above), BPL households with a maximum of 1000 W connected load shall be given free connection (WP with support posts / post insertion plus a maximum of 200 m OH), using the KSEBL fund, till the end of the plan period 2018-22 or till the fund of Rs 50 Crores allotted for "continued electrification" in the plan fund for the period is exhausted, as long as there are no other specific schemes in place for granting electricity connections to BPL households free of cost.

The Executive Engineer, Electrical Division, Tirurangadi reported that the case is genuine and electric connection is very essential for attending on line classes.

The matter was placed before the Full Time Directors as per note read as 5th above.

Having examined the matter in detail, the Full Time Directors in the meeting held on 11.06.2021 resolved to accord sanction to the the Executive Engineer, Electrical Division, Tirurangadi to effect the single phase service connection in favour of Sri. Rajesh, S/o Subrahmanian, who comes under BPL category for attending on line classes for his daughter, by constructing 237 meters of LT single phase two wire line with 6 nos of LT Poles and 25 mtr of WP portion amounting to Rs 90490/- using Board's fund as a special case.

Orders are issued accordingly.
