## **ORDER**

It was further resolved to authorize the Chief Engineer(HRM),KSEBL to disburse the remuneration of Rs 30,000/- (Rupees Thirty Thousand Only) per month inclusive of all expenses to Sri Radhakrishnan.C, Retired Spl.Dy.Tahsildar, KSFE(RR) based on the monthly attendance certificate forwarded by the Chief Co-ordinator, Land Management Unit with effect from May 2021.

The Chief Co-ordinator, LMU & Chief Engineer (HRM) shall initiate further course of action in this regard.
