ORDER

The *Lower Periyar HE Project* (3 x 60 MW) was commissioned during 1997. The retaining wall along the river side /tail race side of the Power Station having length of 200m had completely collapsed, during the deluge on 15.08.2018.

Subsequently KSEB Ltd. decided to re-construct the damaged retaining wall along the river side /tail race side of the Power Station and accordingly sanction was accorded as per order read as 1st above to carry out the subject work of re-constructing the damaged portion of the retaining wall at *Lower Periyar HEP* by entrusting the same to the Chief Engineer(Civil Construction South).

The Chief Engineer(Civil Construction South) as per note read as 2nd above reported that the only office under his jurisdiction available adjacent to *the Lower Periyar HE Project* (3 x 60 MW), is the *O/o The Project Manager , Thottiyar HEP* and the office is entrusted with the work of execution of *Thottiyar HEP* which is progressing in full swing and hence the officers under his jurisdiction cannot be spared for execution of the said work. He further informed that the design drawings required for the said work can be issued from his office.

In these circumstances, the Director(Generation Civil) as per note read as 3rd above suggested to review the sanction accorded as per order B.O read as 1st above to entrust the execution of the work with Dam Safety Division Pambala under the control of the Chief Engineer (Civil DS&DRIP) and the preparation and issue of the design drawings required for the said work be entrusted with the Chief Engineer (Civil Construction South).

Accordingly the matter was placed before the meeting of the Full Time Directors as per note read as 3rd above for approval. Having considered the matter in detail the Full Time Directors in the meeting held on 28.05.2021, resolved to review the decision as per B.O

entrust the work of *re-constructing the damaged retaining wall along the river side /tail race side of the Lower Periyar HE Project (3 x 60 MW)* with Dam Safety Division Pambala under the control of the Chief Engineer (Civil DS&DRIP) and the preparation and issue of the design drawings required for the said work shall be entrusted with the Chief Engineer (Civil Construction South).

Orders are issued accordingly.


