ABSTRACT

Purchase of a new tempo traveler for the use of the Line Maintenance Section (LMS), Angamaly – sanction accorded – Orders issued.

ORDER

The departmental vehicle (Tempo Traveler 1996 model) attached to the LMS Angamaly was survey reported due to frequent breakdown and non availability of spare parts. Since the service of a Tempo Traveler was essential for attending breakdown and maintenance works under LMS Angamali, sanction was accorded as per B.O read as 1st above, for hiring a tempo traveler with driver with a ceiling of 2000 km per month, on contract basis.

The Chief Engineer, Transmission North has reported as per letter read as 2nd above that, through tenders were invited four times, no valid offer could be obtained. At present all the works of LMS Angamaly are being carried out by hiring vehicle on monthly contract basis. As the fuel consumption will more due to travel through kutcha roads, vehicle owners who have quoted for supply of vehicle for one month is not willing to continue their contract for succeeding months. Therefore procurement of a new vehicle is the only solution to the crisis faced by the LMS Angamaly.

It is further reported that, most of the tower locations under this LMS are at isolated areas in forest land. So, it has to be accessed through kutcha roads for carrying out breakdown and preventive maintenance works.

The Chief Engineer, Transmission North has submitted an estimate amounting to Rs.14,88,577/- for purchasing a new vehicle (Tempo Traveler 14+1 seating capacity). The cost on account of this purchase can be met from the budget provision for the purchase of new vehicle for the financial year 2021-22 of

The matter was placed before the Full Time Directors as per Note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 17.05.2021.

Resolved to accord sanction to purchase 1 No. Tempo Traveler (14+1 seating capacity) for the use of Line Maintenance Section, Angamaly through GeM Portal. The approximate financial commitment due to this purchase is Rs. 14,88,577/-

Further resolved to authorize the Deputy Chief Engineer, Transmission Circle, Thrissur to arrange the purchase, observing all formalities.
