ABSTRACT

Manufacture and supply of 8m and 9m PSC Poles from Department yard at Mananthavady to Electrical Circle, Kalpetta for a period of 2 years – Tenders invited – Placing Purchase Order -sanctioned – orders issued - reg.

ORDER

KSEBL as per B.O read as Ist above had accorded Administrative Sanction for an amount of Rs. 275 Crore for the manufacture and supply of 5,91,700 Nos. of 8m and 2,79,600 Nos. of 9m PSC Poles in all the 25 Electrical Circles for next two years from private yards and from two departmental yards at Mangattuparamba and Mananthavady. Accordingly two part e-tender was invited by the Chief Engineer (SCM) for the manufacture and supply of 22,000 Nos. of 8m and 8,000 Nos. of 9m PSC Poles from Department yard at Mananthavady to Electrical circle, Kalpetta for a period of 2 years vide Bid No. KSEB/SCM/eP-48/2020-21 dated 04/11/2020, with a probable amount of contract of Rs. 922 Lakh.

The price bids of the pre-qualified bidders were opened on 06/02/2021. The lowest bidder was M/s. Sharpline Builders & Developers. The proposal was placed before the Purchase Sub Committee to decide whether to authorize the Chief Engineer (SCM) to place Purchase Order with M/s. Sharpline Builders & Developers against Bid No. KSEB/SCM/eP-48/2020-21 dated 04.11.2020 for the manufacture and supply of 8m and 9m PSC Poles from Departmental yard Mananthavady to Electrical circle, Kalpetta for 2 years, involving a total financial commitment of Rs. 6.7 crore (excluding GST) as detailed below:

The Purchase Sub Committee meeting held on 10/03/2021 discussed the agenda as per item no.51/20-21 in detail and the proposal is approved, subject to the condition that, prior permission shall be obtained from Election Commission before placing the Purchase Order.

As the stay order on Bid No. KSEB/SCM/eP.46/2020-21 invited for PSC poles in 23 Ele.Circles is still existing, legal opinion was sought from LA&DEO, KSEBL for issuing purchase order against the tender invited for manufacture and supply of PSC from Mananthavady yard. The LA & DEO as per note read as 2nd above opined that "Board may purchase PSC poles if the same is limited for the purpose for which permission is granted vide interim order dated 05.04.2021 of the Hon'ble High Court of Kerala".

The matter was placed before the Full Time Directors by the Chief Engineer(SCM), as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 21.05.2021 resolved to authorize the Chief Engineer (SCM) to place Purchase Order with M/s. Sharpline Builders & Developers against Bid No. SCM/eP-48/2020-21 dated 04.11.2020 for the manufacture and supply of 8m and 9m PSC Poles from Department yard at Mananthavady against the number of damaged poles to Electrical circle, Kalpetta.

Orders are issued accordingly.
