M/s. Seaboy Fisheries (P) Ltd. (LCN 1/148) – Settlement of Current Charge arrears – Under OTS Scheme 2021 – Sanctioned – Orders issued.

### ORDER

M/s. Seaboy Fisheries (P) Ltd. erstwhile Company Euro Marine (HTB 1/148) is a live HT consumer under Electrical Circle, Thiruvananthapuram (Urban) has outstanding arrears amounting to ₹ 65,02,732/- as on 31.03.2021 (including interest) towards the APTS bill issued during 03/2005 and short assessment bill for the period from 05/1999 to 02/2003 .

Now the consumer M/s. Seaboy Fisheries submitted an application on 04.03.2021 for consideration of settlement of arrear under OTS Scheme 2021. The APTS bill was arised due to theft of energy detected by APTS on 09.03.2005. As per the procedure and guidelines of the OTS 2021, the assessment in connection with theft of energy cannot be considered for OTS and this was informed to the consumer .

The consumer M/s. Seaboy Fisheries again submitted an application before the Chairman & Managing Director, KSEBL stating that the company is now running under new management and the theft case relating to the APTS bill was detected by APTS during the period of old management and they are doing prompt payment of current charges. They also agreed that they are ready to settle all the current charge arrear - APTS bill - ₹ 8,96,168/- plus interest and the short assessment bill by Audit Wing of

KSEBL for ₹ 10,20,134/- plus interest (dispute vide pending case in Hon'ble High Court of Kerala) and requested to consider for the benefit of OTS Scheme 2021.

After examining the matter in detail, the Chairman & Managing Director has ordered to place the matter before Full Time Directors for taking a decision since the present consumer has not done any theft and ready to settle the arrears under OTS Scheme 2021. The Deputy Chief Engineer, Electrical Circle, Thiruvananthapuram as per note read 4<sup>th</sup> above reported that no criminal case was registered against the consumer M/s. Euro Marine in connection with the theft of energy since 09.03.2005.

The matter was placed before Full time Directors as per note read 5<sup>th</sup> above. Having considered the matter in detail, the Full Time Directors in its meeting held on 21.05.2021 resolved to permit the present consumer M/s. Seaboy Fisheries (P) Ltd. (LCN 1/148) to clear the arrears (APTS bill) amounting to ₹ 8,96,168/- (Principal amount) along with the short assessment bill amounting to ₹ 10,20,134/- (Principal amount) for the period from 05/1999 to 02/2003 with applicable interest in the OTS Scheme 2021, since the present consumer M/s. Seaboy Fisheries (P) Ltd. has not done any theft, considering that the application for OTS was received before 31.03.2021 and that they are willing to settle the arrears under OTS 2021 on the condition that the consumer will withdraw the case WP (C) No.31741/2015 filed before the Hon'ble High Court of Kerala against the short assessment bill of ₹ 10,20,134/-.

Orders are issued accordingly.
