Inspection Bungalows in Dam Safety Organisation building at Pallom and in the KSEBL office/colony premises in Vazhathope named 'Kolumban House' – Sanction for commencing the operation -Orders issued.

ORDER

The two Inspection Bunglows, one in the Dam Safety Organisation building at Pallom and the other one at the KSEBL office/colony premises in Vazhathope named 'Kolumban House' are furnished and presently ready to function by commencing allocation of rooms.

A. <u>Inspection Bungalow setup in the Dam Safety Organisation (DSO) building at Pallom, Kottayam:</u>

The Chief Engineer(Civil- Dam Safety & DRIP)as per the note read as 2nd above has reported that the IB, which is setup in the second floor of DSO building consists of 7 rooms - 5 double rooms (3 A/C and 2 non A/C) and 2 dormitories with 4 beds in each. The furnishing works of the IB is completed in all respects. The Chief Engineer suggested categorizing this IB as B – Grade.

The Chief Engineer(Civil- Dam Safety & DRIP) requested to restrict allocation of rooms in the IB exclusively for KSEBL officials for the reason that there is no independent entrance for the IB, in the DSO building where sensitive installations are equipped.

Further, the Chief Engineer has requested permission for engaging one caretaker cum cook and a part time cleaner on contract basis for the upkeep and maintenance of the IB.

B. Kolumban House at Vazhathope:

The Chief Engineer (Civil- Dam Safety & DRIP) as per the note read as 3rd above has reported that the newly constructed Inspection Bungalow at Vazhathope named 'Kolumban House' is intended for the accommodation of VIPs and officers of KSEBL above the rank of Executive Engineer. The fully air conditioned IB consists of 6 rooms (2 VIP rooms and 4 double rooms), 3 dormitories (3+3+4=10 beds) besides a conference hall. Now the furnishing works of the IB are completed in all respects. The Chief Engineer suggested categorizing this IB as A – Grade and requested sanction for engaging one caretaker cum cook and a part time cleaner on contract basis.

The matter was placed before the Full Time Directors as per the note read as 4th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 21.05.2021 resolved to accord sanction for operation of the Inspection Bungalow set up in the Dam Safety Organization Building, Pallom under the following conditions.

- i) To categorize as a B Grade Inspection Bungalow
- ii) To engage one Caretaker cum Cook and a part time Cleaner on contract basis.
- iii) To allocate rooms through the office of the Secretary(Administration), KSEBL restricting it to the officials of KSEBL alone.

Further resolved to accord sanction for operation of the newly constructed Inspection Bungalow at Vazhathope named 'Kolumban House' under the following conditions.

- i) To categorize as a A Grade Inspection Bungalow
- ii) To allocate rooms for the officials of KSEBL and other dignitaries through the office of the Secretary(Administration), KSEBL.
- iii) The existing Cook-cum-Caretaker and Cleaner shall look after both the Inspection Bungalows.

Orders are issued accordingly.
