## ABSTRACT

## ORDER

Purchase Orders read as 3<sup>rd</sup> above were placed with M/s Crompton Greaves Consumer Electricals Ltd and M/s H.Q. Lamps Manufacturing Co. Pvt. Ltd for the supply of 70 Lakh and 30 Lakh, 9 Watt LED bulbs respectively under Filament Free Kerala Programme, based on the B.O read as 2<sup>nd</sup> above.

As per the POs read as 3<sup>rd</sup> above, One Crore LED bulbs had been received at 25 Electrical Circles.90.04 Lakh LED bulbs have been distributed among the consumers as on 17.5.2021. Present availability of LED bulbs at stores is 9.95 Lakh. The buffer stock to be kept in SRS(2% of total procurement) is 2 Lakh. Considering the present requirement (28.11 Lakh), there is a shortage of 21 Lakh LED bulbs (including buffer stock) for completing the programme.

The matter was placed before the Full Time Directors for decision, as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 17.5.2021,

1. Resolved to accord sanction to initiate the process of purchasing 25% additional quantity, (ie 25 Lakhs) of 9W LED bulbs for completing the Filament Free Kerala Programme.

 Further resolved to seek the willingness of the firms, M/s Crompton Greaves Consumer Electricals Ltd and M/s HQ Lamps Manufacturing Co. Pvt. Ltd, for supplying LED bulbs at the same rates, terms and conditions of the original purchase order.

Orders are issued accordingly.
