




Purchase of ACSR Rabbit Conductors - Sanctioned - Orders issued.

## ORDER

Two part open tender was invited for the procurement of 65,865 km ACSR Rabbit and 7,310 km ACSR Raccoon Conductors on variable price basis as per bid read as 4<sup>th</sup> above with the PAC of Rs.296 Crores to meet the requirement for the Financial Year 2021-22.

As per the decision of the Full Time Directors of KSEBL in the meeting held on 16/04/2021, it was directed to place before the Board of Directors for sanction to issue Purchase Orders for 50% quantity of Rabbit conductors with Circle wise L1 bidders (7 nos. of outside state Bidders) at the all inclusive L1 rate of Rs. 39557.14 per km with IEEMA price variation as per G.O read as 1<sup>st</sup> above against the bid. The total financial commitment will be Rs.130.27 crores. The balance quantity reserved for M/s. Traco Cable Company(State PSU) and local MSMEs to be finalised after getting modified order from the Government regarding division of quantity.

The acute shortage of Rabbit conductor is being reported by the Deputy Chief Engineers of Electrical Circles even for effecting service connections. Further in the scenario of the outbreak of second wave of Covid 19 pandemic, uninterrupted power supply must be ensured to the hospitals and Covid FLTCs. The Director(D,IT & HRM) as per note read as 6<sup>th</sup> above has intimated that several sections have run out of stock of Rabbit conductors,consequent to the damages in the ongoing natural calamity. To meet the requirements in the coming days following the expected monsoon rain, sufficient stock of Rabbit Conductors are to be ensured in all Circles. The item is fast moving one and the monthly requirement of ACSR Rabbit is 9000km (approx.).

Considering the urgency, the matter was placed before Full Time Directors as per note read as 7<sup>th</sup> above. Having considered the matter in detail, the Full Time Directors in the meeting held on 17/05/2021, resolved to accord sanction to authorize the Chief Engineer (SCM) to place Purchase Orders for the supply of 32,933 km (50% of the tendered quantity) of ACSR Rabbit conductors with

circle wise L1 bidders (7 nos. of outside state bidders as per table below) at their all inclusive L1 rate of Rs.39,557.14 per km with IEEMA price variation,as per Governemnt order dated 18/09/2020 in order to meet the urgent requirement in anticipation of sanction from Board of Directors due to acute shortage of conductors. Total financial commitment will be **Rs.130.27 Crores.**
