Theft of electricity committed by Raveendran Nair on 23.01.2008 – Death of accused Raveendran Nair in a road accident on 13.10.2018 – Settlement of arrears under OTS scheme after withdrawal of the Writ Petitions filed by the consumer - Sanctioned – Orders issued.

ORDER

Sessions case No. 205/15 was charged against Sri. Raveendran Nair for the theft of electrical energy and the same was abated on 19.06.2019 due to the death of the accused.

Smt. Ponnamma Nair, wife of late Raveendran Nair, informed the Assistant Engineer, Electrical Section, Mulakuzha that she is willing to remit the bill amount in OTS scheme and not interested in proceeding with the case against KSEBL before the Hon'ble High Court.

The matter was placed before Full Time Directors as per note read 2 above. Having considered the matter in detail, the Full Time Directors in its meeting held on 31.03.2021 resolved to accord sanction to extend the benefit of OTS Scheme to legal heir of the deceased Raveendran Nair on condition that the benefit shall be extended only after the withdrawal of the writ petition/s filed against KSEB Limited.

The decision to pass orders as above was taken on 31.03.2021 which is during the currency of Model Code of Conduct (MCC) ordered by the Election Commission of India. Orders has now been issued after lifting of Model Code of Conduct (MCC). The Deputy Chief Engineer, Electrical Circle, Haripad shall take necessary steps to consider the matter under OTS scheme
