ORDER

M/s. Poisha Industrial Company Ltd. (LCN/ 2/226) is an HT consumer which comes under the jurisdiction of Electrical Circle ,Ernakulam .They have defaulted in the payment of current charges from 03/1994 to 01/1995, amounting to Rs.1,03,567/-(excluding interest). Due to the default of payment of current charges, the service connection was disconnected on 05/07/1994 and subsequently dismantled.

An OTS offer letter has been forwarded to the consumer with a copy to the Assistant Engineer, Electrical Section, Edapally. In reply to the offer letter, the Assistant Engineer has informed that the original consumer has sold the property to Matha Amrithananthamayi Math and the old buildings are in demolished condition. It is also intimated that there is a new building having an existing electric connection bearing Cons no.1155443030418, LT 7A in 3 phase with the date of connection, 26/05/2018. So the OTS offer letter couldn't be handed over to the new party in that premises.

On 25/03/2021 the existing consumer ,Amrita Institute of Medical Science has forwarded an email read as 2nd above ,intimating the willingness to settle the arrears at

OTS rate.

The matter was placed before the Full Time Directors ,KSEBL . Having considered the matter in detail ,the Full Time Directors,KSEBL, in its meeting held on 8/04/2021 resolved to permit the consumer to clear the arrears under OTS scheme 2021.

The decision to pass orders as above was taken on 8/04/2021, which is during the currency of Model Code of Conduct (MCC) as ordered by Election Commission of India .Orders has now been issued after lifting the MCC.
