#### ORDER

The Chief Engineer (IT, CR & CAPs) as per note read as 2<sup>nd</sup> above has reported that, as part of promoting online new service connection applications, KSEBL as per BOs, read as (1&2) above, had accorded sanction to waive application fees for new service connection applications submitted through online upto 31.03.2021 and decided to review the program at the end of first year. The Kerala State Electricity Regulatory Commission has also approved the exemption of application fee for new service connections submitted through online upto 31.03.2021.

The Online new connection application fee waiver was introduced from 01.01.2020. During the above period, only 35% of LT and 11% of HT new connections applications were received online.

In-order to promote online new service connection applications further and to reduce the personal visit of applicants to section office in the present Covid-19 situation, the Chief Engineer (IT, CR & CAPs) recommended to extend the waiver of online new service connection application fee for a further period of one year from 31.03.2021.

The matter was placed before the meeting of Full Time Directors as per note read (3) above. Having considered the matter in detail, the Full time directors in its meeting held on 16.04.2021 resolved to accord sanction to extend the waiver of application fee for new service connection applications submitted through online for one more year from 31.03.2021.
