Extension of period of retaining ADSS for further period of 1 year (24-3-2021 to 23-3-2022) along Nallalam — Kaniyabetta 220kV EHT line — Realisation of rental charges from M/s Reliance Infratel Ltd. - Sanction accorded - Orders issued.

ORDER

M/s. Kerala Communication Network Private Limited [(KCN Limited), a Reliance Group Company] was permitted by KSEB in 2002 to lay fibre optic cable along Nallalam-Kaniyambetta 220kV line and rental charges for the fibre optic cable was being realised from them from 2003 onwards. Later the firm changed their name as Reliance Communications Infrastructure Limited and accordingly invoices for the rental charges for retaining the ADSS fibre optic cable was being raised in the name of M/s.Reliance Communications Infrastructure Limited from 24.03.2012 onwards. The Administrative Sanction was accorded by KSEBL as per order read as 1st above for the realisation of annual rental charges @ Rs 1,62788/km/ year/ cable from M/s. Reliance Communications Infrastructure Limited for retaining their ADSS fibre optic cable along Nallalam-Kaniyambetta EHT transmission towers for the period from 24.03.2020 to 23.03.2021.

As the validity of the rental charges had expired, the Chief Engineer (Transmission North) as per letter read as 2nd above requested for revising the rental charges. Hence the Chief Engineer (Transmission - System Operation) as per letter read as 3rd above, has remarked that the annual increase in rent rate may be fixed as 5% hike of the previous years rental charges. The rent fixed for the year 2021-22 is Rs.170927 /km/cable/year, then the total demand towards the rental charges will be Rs 1,29,08,437/- (including GST). The Chief Engineer (IT,CR&CAPS) as per letter read as 4th above has recommended, subject to the

condition that the renewal of rental charges of M/s.Reliance Infratel Ltd along the EHT line may be allowed for a maximum period of 1 year from the date of sanction or till the OFC of the operator is migrated to KFON whichever is earlier.

In view of the above, it is recommended to fix the rental charges of M/s.Reliance Infratel for a maximum period of 1 year from the date of sanction or till the OFC of the operator is migrated to KFON whichever is earlier.

The matter is placed before the Full time Directors as per note read as 5th above seeking decision.

Having considered the matter in detail, the Full Time Directors in the meeting held on 26/3/2021,

Reolved to accord sanction to extent the period of retaining ADSS Fibre Optic Cable along Nallalam-Kaniyambetta through EHT Transmission Towers in favour of M/s Reliance Infratel for a period of one year (24.3.2021 to 23.3.2022) from the date of sanction or till the OFC of the operator is migrated to KFON whichever is earlier.

Further resolved to realize the annual rental charges @Rs.170927/km/year/cable(ie with a hike of 5% of the rent for the period from 24.3.2020 to 23.3.2.21)

Orders are issued accordingly.
