ORDER

The Marmala Small Hydro Electric Project is proposed as a run-of-the river scheme in Marmala thodu, one of the main tributary of Meenachil river in Poonjar village at Thalanadu Grama Panchayath of Meenachil Taluk in Kottayam District. The installed capacity of the scheme is 7 MW and the expected annual generation is 23.02 MU.

KSEBL as per B.O read as 1st above has accorded administrative sanction for the implementation of Marmala Small Hydro Electric Project for an amount of Rs 56.10 crore including IDC and MNRE subsidy at 2012 price level.

The project requires 7.4726 Ha. of land including 5.9099 Ha. patta land and 1.5627 Ha. non patta land of which 0.5326 Ha. of non patta land is under the possession of private land owners. Government as per G.O read as 2nd above had accorded sanction to the District Collector, Kottayam to resort to direct/negotiated purchase of an extent of 5.9099 Ha. of patta land in Thalanadu and Teekoy Village of Kottayam District for the implementation of the project.

The Chief Engineer(Civil -Construction South) as per note read as 3rd above has reported that as requested by the Special Tahasildar, LA (General), Pala, the requisition for acquisition of 5.9099 Ha. of land in Teekoy and Thalanadu Villages of Kottayam District as per LARR Act 2013 in the prescribed form has been submitted to the District Collector,

Kottayam by the Project Manager. Further, the Special Tahasildar, has forwarded the details of establishment charge amounting to Rs 26,29,460/- (30% cost of compensation based on fair value) and contingency charge amounting to Rs 4,38,243/- (5% cost of compensation based on fair value) for remittance so as to proceed with the land acquisition activities.

The Chief Engineer(Civil -Construction South) has requested sanction for remitting Rs 4,38,243/- as contingency charges (5% cost of compensation based on fair value) for the land acquisition activities of Marmala SHEP.

The matter was placed before the Full Time Directors as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 30.04.2021 resolved to accord sanction for remitting Rs 4,38,243/- (Rupees Four Lakh Thirty Eight Thousand Two Hundred And Forty Three only) as contingency charges for the land acquisition activities of Marmala SHEP.

Orders are issued accordingly.


